At Norge Mineraler, he will lead the development of the Company's Bjerkreim Exploration Project through pre-feasibility and feasibility studies and then through the planning and subsequent stages leading to production.

The Company's Mineral Resource Estimates from the Bjerkreim Exploration Project have confirmed world-class deposits of the EU Critical Raw Materials phosphate and vanadium along with large quantities of titanium.
